## Joint Message from CRKN's Executive Director and Chair of the Board

On behalf of the CRKN Board of Directors, we are pleased to present our new Strategic Plan for 2019-2024.

This is the first strategic plan launched with CRKN's expanded mandate of access to knowledge through both licensing and negotiation of scholarly content, and the preservation of and access to digital documentary heritage. In the creation of this plan, we heard from our members and stakeholders, that as an organization, and as a community, we are uniquely positioned to collaborate on the initiatives, projects, and approaches that will further transform access to knowledge for a Canadian-led innovative global society. That is our context, and our charge, for this strategic plan.

# Strategic Goals

### 1: Transform Scholarly Communication

Transformation is at the core of our business. In 1999, the Canadian National Site Licensing Program was created to provide an innovative infrastructure to increase Canada's research capacity. Building on our successes, today, we define and put in to place the next act of CRKN's innovative approach to access to knowledge.

As a national voice, a community of practice, and the national collective negotiating body for research content academic libraries in Canada, CRKN will:

- → Develop a set of principles that drive the negotiations, approaches, and decisions that underpin CRKN's state-of-the-art licensing program;
- → Champion different models of open access, in Canada and internationally, that achieve widespread access to knowledge;
- → Lead by example by increasing the accessibility and decolonized discoverability of the dynamic Canadiana collections, ensuring that this unique content is available for research and personal use, now and for future generations;
- → Lead in the digital preservation of heritage content by respecting Indigenous Ways of Knowing and by building interoperable systems and expanding access and preservation services for the Canadian community.

### 2: Develop and Foster Partnerships

CRKN is a network, a group of interconnected institutions, working collaboratively to achieve more together than they could apart. The CRKN network extends beyond its members to include stakeholders, galleries, libraries, archives, and museums (GLAMs), and individuals who benefit from the content made available by CRKN. Innovation is most effective when done in collaboration. CRKN is committed to working in partnership to meet shared goals.

As a national voice, a community of practice, and the national collective negotiating body for academic libraries in Canada, CRKN will:

- → Strengthen relationships with national and international stakeholders and ensure Canada is well represented as leaders of key global initiatives;
- → Collaborate to enhance scholarly communication infrastructure and leverage partnerships to advance strategies and access funding;
- → Foster inclusivity and encourage diverse representation and participation in CRKN initiatives:
- → Enhance the connection between CRKN's heritage content program and the Canadian GLAM community, aligning and working toward the National Heritage Digitization Strategy.

### 3: Collaborative Advocacy

Canada's role in open scholarship is crucial for the development of an innovative and informed society. CRKN's members and stakeholders have connected around a shared vision of expanded access to knowledge and a commitment to public access to publicly funded research. Sharing this vision and encouraging action locally, regionally, and nationally will take coordinated efforts and clear and consistent messaging for how stakeholders can support these goals.

As a national voice, a community of practice, and the national collective negotiating body for academic libraries in Canada, CRKN will:

- → Harness the collective voice of CRKN members and partners to amplify and advance issues:
- → In collaboration with stakeholders, define and put into action the Canadian approach to open access;
- → Champion the use of data to inform decision-making, resource development, and strategies to transform scholarly communications;
- → Highlight and mobilize the success of CRKN and its members locally, regionally, nationally, and internationally.

# Transformation in Action:

## CRKN's Strategic Project

Strategic plans provoke action, galvanize support, and most of all, create a framework for meeting bold and audacious goals. Underpinning the three strategic goals described in the 2019-2024 strategic plan is the need for a clear, defined Canadian approach to open scholarship.

Through this strategic project, CRKN acknowledges that member and stakeholder needs and perspectives regarding open access are diverse, grounded in the contexts and communities in which we work. The approach of this strategic project includes a balance of bold steps paired with the smaller but equally critical foundational steps, all making a meaningful impact to bring us closer to our vision.

### A CRKN Approach to Open Scholarship: A Multipronged Strategy to Advancing Access to Knowledge

As a national voice, a community of practice, and the national collective negotiating body for academic libraries in Canada, collaborating with partners and stakeholders, CRKN will develop a national strategy for access to knowledge.

To develop the Canadian approach, CRKN will:

- → Collaborate with members and stakeholders to develop a list of principles to guide CRKN's open scholarship vision;
- → Collaborate to create a vision document and key messaging to leverage advocacy opportunities and galvanize stakeholder support;
- → Champion advocacy and engagement strategies with researchers, university administrators, funders and other partners;
- → Collect and analyze data that supports this transformation and defines the output of scholarship in Canada;
- → Create resources and toolkits to support, advance, and enable conversations across and within institutions in Canada.
